Minutes of the Board of Trustees Meeting
January 28, 2021

CALL TO ORDER – INVOCATION

The meeting was called to order by President Barbara F. Weston at 6:10 p.m. Following the Call to Order, Gary Geiger gave the Invocation.

MEMBER COMMENT PERIOD

There were no members present or online during the Member Comment Period.

SAFETY REPORT

Barbara Weston reported that the Committee met on January 28, 2021 and reviewed the expense reports and credit card invoices for the Board, CEO, and Attorney for the period December 1-31, 2020. All accounts were approved by the Audit Committee and that an audit credit will be applied to next month's statement.

CENTRAL UPDATE

Mr. Lowder discussed the January Central Board Meeting Summary, a letter from Jim Lamb to Vicky Budreau regarding the cooperatives' dissatisfaction with Santee Cooper, and Marlboro Cooperative. Also, Mr. Lowder announced that he stepped down as Chairman of the Member Services Committee for Central due to the fact that he has been appointed to the Executive Committee. Barbara Weston has been appointed to Chair the Member Services Committee.

STATEWIDE UPDATE

Mr. Lowder reported that House Bill 3194 regarding the sale or reform of Santee Cooper has come out of the House and is in the Senate. Tri-County tied with Edisto and Lynches River Cooperatives for first place in our division of the President's Safety Contest. The following items were posted in BoardPaq: the local pages of the *South Carolina Living* magazine and a letter from Mike Couick to Governor McMaster offering to assist in deployment of the COVID-19 vaccine by use of the cooperatives' facilities.

OLD BUSINESS

TRICO GLOBAL INDUSTRIAL SITE UPDATE

Chad Lowder reported that the sewer pump stations are being finalized now and the full infrastructure including natural gas is slated to be completed by the end of March. Additional information will be covered in the economic development comments.
